2025/67) Approval of last meetings minutes

2025/73) Planning

1. Current planning applications

Application no 11/25/001. Demolition of barns and erection of 5 No dwellings (replacing prior approval for 5 No dwellings) with associated works at Greenacre Lane Livery. This was originally a Class Q application that was approved and then a betterment scheme was submitted. The new application is a modification on design and layout with minor changes to the building materials. The planners wished to have a more contemporary look. There are not enough changes for the Parish Council to add to its comments submitted on 5th March.

1. Bank Reconciliation

The RFO read out a bank reconciliation list. The Councils current account has £58 and there is £20,000 in the savings account.

2. CIL Submission Update

We received CIL money on new builds in June 2023 and Oct 2024, and this has to be spent within 5 years of the funds received. The Council have to submit a yearly report on spending this money and what it was used for. There were minor errors in the report submitted. The RFO has supplied copies of the bank statements to prove the dates when these were funds were received. We have not heard anything further from Somerset Council yet.

2025/75) Topics raised at the Annual Parish Meeting

Graveyard extension: there is no land that is for sale at this time that can be purchased for this purpose. If any land did come for sale there is someone who would be happy to purchase this and then gift the land to the church for this purpose.

Cllr Passingham is going to raise the issue of re-purposing land for the old graveyard.

We are still waiting for input from Somerset Council on what the CIL money can be used for. Once we receive further information we can understand what is viable on the list generated at the annual parish meeting.

2025/76) Highways and Footpaths

1. Clear and accessible footpath on T7/2

The environment agency were informed that the footpath was blocked, they marked the footpath with white powder and the next day the farmer cut a two-meter-wide strip through the maize. This item is now resolved and can be removed from the agenda.
