3. Investment accounts?

The RFO suggested that we could invest the money we currently have in the savings account? We will have the money for a while as there are no large upcoming finances. Maybe we can do an instant access account. This will require research as if there are any unexpected expenses money needs to be accessible.

2025/93) Topics raised at the Annual Parish Meeting

1. CIL funding, consider the suggestions raised at the annual parish meeting.

The list of potential projects was submitted to Somerset Council in July, reply was received in

September.

School bus shelter at the village hall: although bus shelters in general are a good use of CIL funds, in this case it was unclear if this was an appropriate use of CIL funds as the shelter was only for children catching the school bus rather than the community as a whole. Furthermore, it would be built on private land belonging to the village hall. It was therefore decided that the Parish Council would write to the CIL officer to clarify the situation.

Defibrillator: Combe Florey Defibrillator Group have requested funds for a third defibrillator to be placed at the pub. In principle, this is a good use of CIL funds and £2000 has been earmarked for this. However, as the existing defibrillators are rented and not owned which means they need to be paid for every four years, clarification needs to be sought from the CIL officer as to whether CIL funds could be spent on a rental/hire agreement rather than an outright purchase.

2. Repair of burial ground railings.

A letter was received from the PCC asking for CIL money to be allocated towards the repair of the wrought iron railings surrounding the burial ground. The CIL officer had rejected all the projects proposed for church property but was not specific about the burial ground. These are grey areas which we will try to clarify with the CIL officer.

The funds can be used for the community as a whole or infrastructure but not for maintenance.

3. Other suggestions raised to be considered by the Parish Council through the year.

2025/94) Highways and Footpaths

1. Any relevant updates

A few parishioners have said the causeway is uneven and needs to be looked at. It is not a footpath and is classed as a highway. Cllr Cleverly will upload a report to Somerset Council's online portal.

There were also some branches overhanging the causeway from the pub, but this now seems to be resolved.

There is occasional sewage overflow into Coggan's Lane from Combe Florey House. Cllr Cleverly will contact the landowner.

Straightening the footpath crossing the B3224 needs an update from Mike Rigby.

While CIL money can be spent on a dog waste bins these have to be a placed somewhere that is legal, accessible, and not on private land. It also has to be a place the recycling teams are willing to empty and is in an area used by dog walkers. Previous investigation into this failed to find a suitable site, and there is some doubt that provision of a bin would help anyway.
