CIL return needs to be submitted. Cllr Hawes has asked for the officer in charge of this at Somerset Council to call him as he has a question over the start date of the qualifying period. We would like to claim for projects dating back to 2021 like the village garden, village pump restoration and the bridge restoration that took place after the Council received the funds but before they were transferred to the PC.

We will need to find a new internal auditor for next year. Our thanks to Sue for all she has done for the Parish Council.

#### Appointment of new RFO for future years 2024/56)

Cllr Hawes states this will be his last Annual Parish Council meeting and he will need someone to take over the RFO role.

For this role good level of skills on spreadsheets, and basic tax and PAYE knowledge is needed. In many councils this role is undertaken by the Parish Clerk, however the current Clerk is unable to undertake any more and has stated she is happy to step aside as Clerk if this is deemed the best approach for the Council.
